# 5. <u>Treasurer's Report – Steve Durante</u>

- Treasurer's Report as per Annual Report.
- \$148,000 in the bank
- No revenue received this year from canteen or Bankstown Sports Club.
- No expenditure on presentations.
- \$24,000 deficit of which \$32,000 represented expenses from the previous year. So from a financial point of view it wasn't a disaster after all.
- Gear sales were down as were registrations more juniors (AKV claim back was higher), less seniors.
- Long Service stepping down after 20 years in the role as treasurer but will still be around.

# 6. Registrar's Report – Wendy Gardner

- We had roughly 926 players, 59 teams excluding fun skills (editor's note; a check 897 players, 61 teams), with 64 coaches, 56 managers. Down on numbers due to the Covid-19 problem but the club had a pretty good year.

# 7. Competition Secretary's Report - Cameron Hume

- As per Annual Report
- The season started as normal but Covid-19 stopped it and, along with most other clubs in the Association we lost players and teams. However six weeks work and a lot of effort was put in to restart the season during which we fielded 77 teams including Fun Skills and played 800 games. Challenges included Federal and State government, FFA, NSW Football, local Council requirements that had to be met.
