- Electricity they have started the process of increasing power to Ted Horwood. Just off Barclay Road a 10 to 15 metre strip of land has been cleared and we are assured that power for the lights will be available for the start of next season.

5. Treasurer's Report – Danny Yu

- We have a breakeven situation. All bills have been paid. Below is an interim financial which is subject to the final external audit.
- Club trading result for 2000 is a surplus of \$10,574 compared with last year's \$141
- Cash balances @ 31st August 2022 \$160,512. Last year \$150,817.
- Registration fee net to BHFC \$54,208. Last year \$56,205.
- Bankstown Sports \$18,669. Last year \$12,206.
- Canteen \$14,066 less & \$10,855 costs (\$3,211, margin 22.8%). Last year \$2,806.
- Donation \$1,500. Last year \$1,000.
- Coaching costs \$8,000, ground hire almost \$19,805, 60 year polo shirts \$18,820.

6. Registrar's Report – Wendy Gardner

- We had 1058 members, 976 players, 63 coaches, 57 managers, 62 teams (not including fun skills).
- I have thoroughly enjoyed the season.

- Nearly had a full season. Missed one round and had a shortened semi and final series.
- Thanked everyone for their patience during the wet weather.
